### 2. Waiver, Release of Liability, Indemnification and Consent Form

For : SA, its Agents and Umpires, Laguna Niguel Girls Softball and the City of Laguna Niguel  
("Released Parties")

I, the undersigned, as the parent or legal guardian of the participant, do hereby give my full consent and approval for my child to participate as a member of Laguna Niguel Girls Softball.

I understand that there are certain risks of damages and injuries, including death, inherent in the practice and play of softball. These risks include but are not limited to those hazards associated with the game itself, weather conditions, and travel, playing conditions, equipment and the acts of other participants.

I understand that the nature of the game of softball is hazardous and risky, including but not limited to risks associated with pitching, throwing, fielding, and catching of the ball; swinging of the bat, running, jumping, stretching, sliding, diving, and collisions with other players or with stationary objects; all of which can cause serious injury or death to my child or to other players.

On behalf of my child and myself, I voluntarily accept and solely assume all risks of injury incurred or suffered as a team member or observer during practice or play.

I hereby certify that my child is fully capable of safely participating in the sport of softball. If my child suffers an injury or develops a condition that may affect her ability to safely practice or play, I will immediately notify the coach and a league official.

I further agree on behalf of myself and my child listed above, that I shall hold harmless and fully indemnify the Released Parties from and against any and all claims, demands, cause of action, damages and liabilities, including but not limited to costs and attorneys fees, howsoever caused, arising directly or indirectly from my child's participation in LNGS sponsored activities. I further agree to pay all reasonable attorneys fees and costs that any of the Released Parties may incur in enforcing any terms or conditions of this Player Agreement.

### 3. Player/Parent Agreement

#### **Commitment:**

Softball is a team sport. When signing up for Laguna Niguel Girls Softball ("LNGS") you agree to participate to the fullest extent. In order for coaches to teach the required skills for team and individual improvement, players are expected to make the commitment to attend practices and games.

#### **Team Assignments:**

Our team selection is based on a draft system. We cannot accept requests for placement with friends or coaches. On a limited basis, our youngest division, 6U, may be grouped by requests.

#### **Volunteering:**

Laguna Niguel Girls Softball is totally run by volunteers, who dedicate their time to providing a quality, safe, and fun learning environment. We would not have all of this without every family assisting in some way. Every family is asked to volunteer to help out, as your contributions to the League are vital.

#### **Waiver of Use:**

I understand that the LNGS may compile and use images, information and photographs of the league activities, games and individuals. I consent to such use and hereby waive all right to compensation.
